CASTLE, CLINT ALLEN	THEFT - GRAND

On the listed date and time, I responded to 400 Drysdale drive in reference to a theft.

Upon my arrival, I made contact Clint Castle (victim), who advised that his trailer had been stolen. The victim advised that he last observed the trailer at 400 Drysdale Dr. at 2000 hours on 6/5/16. The victim stated that he leases the property where the trailer is kept. The property is located at the intersection of Drysdale and Oakleaf Plantation Parkway on an open land.

The victim stated that he came to the property on 6/6/15 at 0930 hours, to retrieve his trailers when he observed his 2013 FORV trailer bearing Florida tag DXTL52, was missing. He advised that the trailer was a 24 foot enclosed trailer and was white in color. The trailer also had a big sign on both sides and on the rear that said "Castle Landscaping give your castle the lawn it deserves (904) 509-7366". The victim advised that the trailer contained lots of lawn equipment valued at \$43,400 and the trailer itself was valued at \$8,500.00.

The victim stated that he had a lock on the hitch portion of the trailer, which must have been cut off by the unknown suspect(s). I search the area for the lock, but was unable to locate it.

The victim did not have the serial numbers for any of the items taken at this time. The victim completed a sworn written statement, which was submitted with this report.

Sgt. K. Smith responded to the scene and took photographs of the scene.

A neighborhood canvass was not conducted due to no homes being in the area of where the trailer was taken.

This case is transferred to the General Investigation Section.
