ON THE <u>12th</u> DAY OF <u>June, 2015</u> AT <u>10:35 AM</u> THE DEFENDANT, AT <u>7380 STATE ROAD 100, KEYSTONE HEIGHTS, FL 32656</u> WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEN AND THERE: commit trespassing and possession of ammunition by a convicted felon by entering the completely fenced and locked property surrounding the closed business of Whitton Roofing, 275 Fox Run Rd, without permission, and after being convicted of a felony in the State of Florida, being in possession of three live rounds of Winchester .25 caliber ammunition at the time of his arrest.  On 06/12/2015 I responded to 131 NE Commercial Circle in reference to a tip that a person meeting the description of a white male robbery suspect, that occurred at 7380 State Road 100 on 06/10/15 (reference to case# 2015016786), was in the business. The white male's physical description and the vehicle he was driving were very similar to the description given of the suspect in the above robbery. When Dep. Kittles and Dep. Clee arrived at the business, the white male who met the description of the suspect immediately fled on foot. I was in the area and observed the white male running towards the fenced in business of Whitton Roofing. The white male was attempting to enter the property of Whitton Roofing, at which point I identified myself as a Deputy, and told him to stop to prevent him from trespassing. The white

male ran down the fence line and tore a piece of the fencing back. The white male then entered the property through the fence. At this point I entered the property and was able to apprehend the white male. The white male was taken into custody and I made contact with the owner of Whitton roofing Monica Whitton. Monica confirmed that the property was fenced to keep people out, and that the white male did not have permission to be on her property. Monica provided a written statement.

At this point, I made the decision to arrest the white male and he was searched by Deputy Clee. Deputy Clee located three live rounds of Winchester .25 caliber ammunition in the white males front right pocket. The white male was identified by his Florida Driver's License located during the search of his person as Thomas Ragonese. It was later discovered that Thomas is a convicted felon. The following information about Thomas's Criminal history was provided by NCIC Operator Wertz:

Convicted on 5/18/2011 for felony possession of controlled substance in St Lucie County.
