Deputy J. Smith asked [redacted] who could have manufactured Methamphetamine at the hotel, and he said the male occupant in room # 111 was asking if anyone would buy him cold medicine.

Sgt. Collins, Det J. Smith, Det. C. Troutt, and myself then relocated to room # 111 and made contact with the occupants (Desaree Midyette and Zachery Gilley). I pulled D. Midyette to the side and read her Miranda from a prepared card. Post Miranda [redacted]

Detective Troutt and Detective J. Smith made contact with Z. Gilley and he was identified by his Florida Identification card (this was also verified in DAVID). I conducted a search through the National Pre-Cursor Log Exchange (NPLEX) on Pseudoephedrine purchases for Z. Gilley. NPLEX showed Z. Gilley had thirty (30) purchases and fourteen (14) blocks since 01-15-2015.

It should be noted that I have received specialized training in the investigation, identification, and clean-up of clandestine methamphetamine laboratories. Furthermore, I have received training in the processing and dismantling of clandestine methamphetamine laboratories. I have been involved in the investigation of approximately 30 clandestine methamphetamine laboratories. The items used to manufacture methamphetamine are common household items however when coupled together present a toxic and hazardous environment.

On 09-22-2015 I was contacted by Detention Deputy Whitman ID # 7658. He told me while booking Zachery Gilley on 09-17-2015 (Case # 2015027066) he noticed his fingerprints were almost burnt off. He said he asked Z. Gilley why he had burn marks on his hands and he responded "[REDACTED]
