ON THE 19th DAY OF September, 2015 AT 12:57 AM THE DEFENDANT,
AT 1099 BLANDING BLVD/JEFFERSON AV, ORANGE PARK, FL 32065 WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEN AND THERE:
commit the offense of discharge of a firearm into an occupied vehicle by firing at the victim's vehicle from the vehicle he was in actual physical control of. The defendant was also operating a motor vehicle within the state of Florida without a driver's license.

On 9/19/2015, the defendant, later identified by his Florida ID card as Christopher Tate, was driving with his girlfriend, involved other Crystal Arzuaga and his step brother, Kush Dave, involved other.

They were traveling north bound on Blanding Boulevard in the eastern lane when the defendant came alongside a red pickup traveling in the western lane. The defendant and the driver of the pickup, Joseph Schaffer, victim and his girlfriend Sarah Robinson, victim became involved in a verbal argument. The verbal argument between the defendant and J. Schaffer took place between the two moving vehicles. The argument ended when the defendant drew a handgun and fired four rounds at J. Schaffer's vehicle.

S. Robinson called the sheriff's office when she observed the defendant point the handgun at the vehicle. As the call was being dispatched Sgt. Lavaron encountered both vehicles on Gifford Avenue. The suspect vehicle pulled into 1415 Remington Court. The defendant exited the vehicle and attempted to enter the residence. While Sgt. Lavaron was giving the subject verbal commands he kneeled down out of sight of Sgt. Lavaron for a brief moment. The subject then stood up and began walking toward Sgt. Lavaron. Following my arrival and after numerous verbal commands the defendant and was taken into custody. C. Arzuaga and K. Dave were then removed from the vehicle and placed into custody.

A search of the open grassy area near the front door area of the residence at 1415 Remington Court, where the defendant knelt down, revealed [REDACTED] handgun. [REDACTED]
