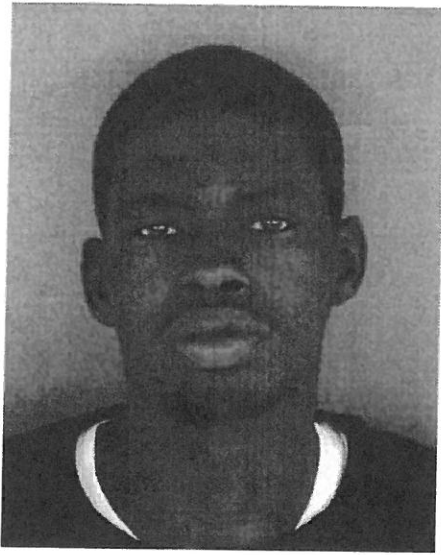

At approximately 1635 hours the described vehicle was observed by the FRFTF traveling in the area of 240 Cheswick Oak Av. in a northerly direction. Deputy United States Marshal [REDACTED] (victim 1 / driver) and Detective [REDACTED] (victim 2 / front seat passenger) were initiating a vehicle stop, utilizing all emergency lighting in specific: two blue 12 inch LED lights in the front windshield and red / blue LED lights in the rear.

As [REDACTED] and [REDACTED] began to initiate the vehicle stop, Miller accelerated the described vehicle, attempted to elude by driving off the road (Miller's right hand side) in the direction of a large / deep concrete culvert. Miller then redirected the described vehicle to his left, where [REDACTED] and [REDACTED] had positioned their agency vehicle (which still had all emergency lighting initiated). Miller continued his path towards [REDACTED] and [REDACTED] in an accelerating motion, showing no regard towards the safety of the public, law enforcement officers and the occupants of his vehicle, which included a young child. Miller then struck the front of [REDACTED] and [REDACTED]'s vehicle with the front of the described vehicle he was operating. Miller was traveling between an approximate 35-40 MPH at the point of collision, which caused air bag deployment on both [REDACTED] and [REDACTED].

Miller's intentional vehicle strike with [REDACTED] and [REDACTED]'s vehicle caused an additional unavoidable collision between Clay County Deputy J. Hawkins (witness) and [REDACTED] / [REDACTED]'s vehicle as he was following with other marked patrol vehicle to assist with the traffic stop.

Once Miller intentionally struck [REDACTED] and [REDACTED]'s vehicle, both vehicles became disabled. [REDACTED] and [REDACTED] were entrapped within their vehicle at which time they held security on the Miller and Reid as additional FRFTF members and Clay County Deputies conducted a felony take down on the two individuals.

Once in custody, the described vehicle was cleared for additional person(s) at which time a young female was located in a child's safety seat. Clay County Fire Rescue was immediately contacted to evaluate all involved person(s) who all appeared to have no injuries and declined medical treatment. Both [REDACTED] and [REDACTED] suffered superficial burns to their arms from airbag deployment. The young female was later released to her mother who responded to the scene.

A vehicle inventory was completed on the defendant's vehicle which revealed a large amount of heroin inside as well as the the wanted homicide suspect.

The defendant (identified by Florida driver's license) was the driver of a Black Ford Expedition bearing Florida Tag (X186QC) and had a subject who was wanted for a homicide out of Philadelphia in the vehicle (2015-035131). The vehicle had been involved in a traffic stop and traffic crash involving US Marshals and CCSO Deputies. D/S Burns further advised me that while searching the vehicle a plastic sandwich baggie containing forty eight individually wrapped pieces of wax paper of a brownish / white colored powdered substance and two smaller plastic baggies containing the same brownish/ white colored substance was discovered underneath the driver's seat and a plastic bag containing a green leafy substance was discovered in the cup holder of the center console. console was a marijuana grinder. D/S Burns conducted a presumptive field test using department issued test kits of both substances and the brownish / white substance tested positive for heroin and the green leafy substance tested positive for marijuana.

I made contact with the defendant who was in custody at the scene and I advised him of his Miranda Warning via prepared card. The defendant was then transported to the Orange Park sub-station by D/S Burns for further questioning. Upon arrival at the Orange Park sub-station the defendant I advised of him of his Miranda Warning again and he signed a Constitutional Rights form and agreed to talk with me about the narcotics.

Post Miranda the defendant admitted

CST C. Adams #7406 responded to the scene and photographed the heroin, marijuana, and grinder prior to it being removed from the vehicle. CST Adams weighed the heroin and got an approximate weight of 15.5 grams total weight. The marijuana weighed approximately 6.5 grams. It should also be noted that the \$862 dollars of U.S. currency that the defendant had in his possession contained seven different types of drug folds of various amounts. When I asked the defendant about the money

authorized the money to be placed into evidence only. CST Adams submitted the illegal narcotics into the Sheriff's Office evidence.

The defendant was transported to the Clay County Jail and booked without incident.

This case is cleared by arrest.
