The victim was reported to be driving a similar vehicle as the one that was at the scene. A partial VIN was located on the burned vehicle at which time it was matched to a VIN attached to a 1998 GMC Savannah registered to Corey Bryan Lane.

On December 16, 2015, Dr. Bausbaum with the Duval County Medical Examiner's Office performed an autopsy on the victim and advised _____
