The complainant advised the victim has not been at her residence since July of 2015 and they provided their neighbor/witness, Bryan Bunker, with the keys to the residence so he could keep the residence secured. She advised they believed people were breaking into the residence while they were gone so they changed the locks and provided the witness with the keys to the residence. The complainant stated her mother/victim is the owner of the house and she moved down to Orlando to live with her because of health issues. The complainant stated there shouldn't be anyone else in the residence and the residence should be secured. I asked the complainant if she was currently with the victim, but she stated she was not because she was out buying groceries. I obtained the victim's number from her and made contact with her at a later time.

I made contact with the witness who advised his wife told him she saw an individual come out of the house on today's date and she did not recognize him. The witness stated he has never personally seen anyone in the residence, but attempted to use his key to open the front door in order to check if the residence was secured, and found the locks had been changed. The witness provided me with the key to the residence. The witness stated he has never given permission for anyone to enter the residence and there should not be anyone inside of the residence without the victim's permission.

I performed a check of the Clay County Property Appraiser's website and found the house still belonged to the victim. I made contact with the victim by calling her cell phone and asked her about her residence. The victim stated she moved to Orlando to live with her daughter because of health reasons. The victim stated all of her personal property is still inside of her residence and nobody should be inside of her house. She stated she provided the witness with a key to her house after she changed the locks and he should be the only one with access to her residence. I asked the victim if she leased her residence to anyone and she stated nobody is renting her residence from her. She stated numerous times she has never given anyone permission to be inside of her residence except for the witness, and there should be nobody inside of her house. The victim gave verbal consent to force entry into the residence using any means necessary in order to get the subject out of her residence.

D/S Burns, D/S Tomlinson, D/S Miller and I approached the residence to observe if anyone was inside the residence. Upon looking through one of the blinds leading into the house, D/S Miller and D/S Burns were able to see a person inside of the residence. I knocked on the front door and D/S Miller and D/S Burns saw the subject run towards the back of the residence. All of the doors and windows leading into the residence were locked and the subject would not come to the front door to open it. While knocking I verbally identified myself as a Deputy Sheriff with the Clay County

Sheriff's Office numerous times, however, the subjects refused to come to the front door. D/S Tomlinson attempted to open the front door using the key provided by the witness, but the locks on the door were new and the key would not work.

I again made contact with the victim and advised her there was an individual inside of her residence. The victim again advised that nobody should be inside of her residence and if someone was inside it was without her permission.

Sgt. Lavaron, Sgt. Ruby and Lt. Gordon all arrived on scene a short time later. Sgt. Lavaron parked his marked patrol vehicle in the front of the house with his emergency lights activated and started to speak to the individual inside of the residence. One of the subjects, later identified as Hunter Webb (Co-defendant) came to the front window of the residence and started to speak with Sgt. Lavaron.

Sgt. Ruby, D/S Burns, D/S Tomlinson, D/S Santiago and I approached the front door of the residence in order to make entry. I used a battering ram and struck the front door one time. The front door opened and contact was made with Webb. Webb began to walk out of the residence, but refused to comply with verbal commands and had to be restrained and placed on the ground. Webb began to resist and attempt to get up off of the ground. Webb was placed in custody and walked away from the residence.

Shortly after Webb exited the residence, another subject, later identified as Shanna Carithers (co-defendant), also exited the residence. She was immediately taken into custody and escorted to a marked patrol car.

Sgt. Ruby, D/S Tomlinson, D/S Santiago, D/S Burns and I began to clear the inside of the residence. Upon entering the residence, a full grown Pit Bull exited a side room and began to bark aggressively at us. I deployed my pepper spray in order to

Due to the defendant being in the residence for approximately 3 weeks without permission, changing the locks to the residence depriving the victim access to her residence and all belongings within, using all of the utilities for the residence which the victim pays for, and refusing to comply with our commands while on scene, the defendant was placed under arrest for burglary and resisting arrest. NCIC/FCIC Operator Hendry #7625 advised the defendant had an active warrant for her arrest out of Duval County and a hold was placed on the defendant. She also advised the co-defendant, Shanna Carithers also had an active warrant out of Duval County, Florida and a hold was also placed on her.

All of the co-defendants were also placed under arrest for burglary and resisting arrest.

I was able to positively identify the defendant by obtaining her personal information and viewing a photograph of her on DAVID. The residence was secured using one of the keys for the new locks which were put on the residence by the defendant, and the witness was provided with the keys.

I was able to positively identify Pons by viewing a prior booking photograph in RMS.

I was able to positively identify Carithers by viewing a booking photograph in LINX from a prior arrest in Duval County, Florida.

I was able to positively identify Webb by obtaining his personal information and verifying it with his mother/defendant and the two co-defendants on scene.
