Jones left hand and he was sweating profusely. J. Jones was detained and identified himself as Justin Jones. He was then advised of his Constitutional rights by D/S Hayden. He admitted

Lieutenant C. S. Gordon #6106 responded to the Shell and observed a black female (later identified as the first co-defendant, Terrell Renee Webb, via her DAVID photograph) standing next to a gold 2005 Honda Accord (FL-3620UL).

The defendant and co-defendants, after being placed under arrest, were transported to the Orange Park Sub-Station where they were placed into interview rooms which were audibly and visually recorded. I advised the defendant of his Constitutional Rights from an agency issued and prepared Miranda Warning form. He completed the form, admitted he understood his rights, and agreed to speak to me. I then requested he ride with me to confirm the locations of the burglaries and he agreed. I and
