ON THE 11th DAY OF May, 2016 AT 3:00 AM THE DEFENDANT,

commit the unlawful offense of burglary to an unoccupied structure by entering in said structure with the intent to commit the offense of theft, contrary to Florida State Statute 810.02(4)(a) and did commit the unlawful offense of resisting an Officer without violence by running from Deputy Sheriff C.E. Welch #469 during the lawful execution of his duty, contrary to Florida State Statute 843-02.

On 05/11/2016 the Clay County Sheriff's Office responded to the El Apache Mexican Restaurant (3rd victim) at 922-2 Blanding Blvd in reference to a burglary in progress. The witness (Brian Florez) reported he that he was sleeping in his business (Cell Phone and Computer Hospital) at 922-3 Blanding Blvd when, at approximately 0435 hours, he heard people talking and moving inside the El Apache Mexican Restaurant. Because his father, Fabio Florez, owns the El Apache Mexican Restaurant he knew it was closed and that no one should have been inside it.

Once Deputy Sheriff C. E. Welch #469 arrived on scene he heard what sounded like glass breaking as he observed two black males (later identified as first defendant
