Commit the offense of manufacturing methamphetamine and trafficking in methamphetamine, contrary to F.S.S. 893-13/1A1 and 893-13/1C1. On 6/15/2016, at approximately 1830 hours, I was advised that patrol deputies had located a possible "one-pot" methamphetamine cook in a vehicle, which was in the parking lot at 1505 County Road 220 at the business of Walmart. Upon my arrival, I made contact with patrol deputies, who advised that they had two white males, later identified as Jonathan Phillips and Brandon Mckinney in custody for retail theft, reference CCR#2016016317. Both Phillips and McKinney were observed getting in and out of a red Pontiac, Sunfire, bearing Florida tag CFIK73, which was parked in the parking lot and occupied by two white females later identified as Adrian Winnie and Michele Paradee. I was advised by deputies that a K9 positively alerted to the odor of narcotics on the vehicle, at which time a search was conducted. Deputies discovered a backpack in the rear seat area. The backpack contained a [REDACTED] bottle, which contained a substance believed to be a "one-pot" meth cook.

At this time, I observed the [REDACTED] bottle, which was on the trunk of the vehicle.

I was able to determine through my training and experience that the bottle was in fact an active methamphetamine cook.

With the assistance of deputies on scene, we evacuated as many vehicles in the area as possible and taped off the area within a safe distance around the car. Due to the bottle being under pressure and having the propensity to fail, causing a fire. Clay County Fire Rescue's Hazmat Team was notified and responded to the scene for safety precautions in case of bottle failure.

Post-Miranda, I asked Michelle Paradee if she wished to talk with me. Paradee stated that she understood her Miranda rights and would speak with me at this time. Paradee advised
