ON THE 23rd DAY OF June, 2016 AT 12:02 PM THE DEFENDANT,
AT 2400 GOLDENROD AV, MIDDLEBURG, FL 32068 WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEN AND THERE:
commit the offenses of unarmed burglary to an unoccupied conveyance (vessel) and grand theft less than \$5,000. The defendant did enter a vessel and remove approximately \$1,710 worth of fishing equipment from the vessel.

On June 26, 2016 the victim, John Hough, reported he was missing 7 fishing poles from the center console area of his boat (vessel). He was cleaning his boat and noticed the fishing poles were missing, so he checked a game camera he had pointed at the boat. The footage showed a white male take the fishing poles from the boat on June 23, 2016 at 1202 hours. The victim was familiar with the suspect and identified the suspect as John Doster (defendant). The victim then went to 2424 Goldenrod Av to confront the defendant. The victim made contact with the defendant's nephew, Shane Simmons. Shane told the victim his uncle, John Doster, was trying to sell 7 fishing poles. Shane later returned one of the fishing poles to the victim.

On July 07, 2016 John Doster contacted Crime Stoppers in reference to turning himself into the Sheriff's Office. Deputy B. Wright arrived at 4527 Redwing Ct and made
