ON THE 28th DAY OF August, 2016 AT 8:07 PM THE DEFENDANT,
AT 3219 RUSSELL RD, GREEN COVE SPRINGS, FL 32043 WITHIN CLAY COUNTY, VIOLATED THE LAW AND DID THEN AND THERE:

did commit the offense of leaving the scene of a crash resulting in injuries other than serious bodily injury when he as a driver of a motor vehicle involved in a crash that occurred on public or private property which resulted in injury to any person, did willfully fail to immediately stop the vehicle at the scene of the crash or as close thereto as possible, or failed to remain at the scene of the crash until he or she fulfilled the requirements of Florida Statute 316.062, contrary to Florida Statute 316.027 (2) (a).

On 08/28/2016, at 2009 hours, I was dispatched to a crash involving a silver Toyota and a motorcycle in the 3200 block of Russell Rd. While enroute, I was informed the silver Toyota had left the scene northbound on Russell Rd.

Upon my arrival, I observed a blue and white motorcycle lying on its side at the driveway to 3219 Russell Rd. The motorcycle had sustained heavy damage from what appeared to be a rear end collision and was missing parts. A BOLO was issued for the silver Toyota, including that the vehicle had a firefighter sticker on the driver

side of the rear window and had heavy damage to the front right corner.

Witness A. Summers stated he observed a silver Toyota driving erratically from I-295 south on US 17. He stated the vehicle was running red lights. He stated when they turned northbound on Russell Rd (CR 209) they were in a long line of cars. He stated the vehicle attempted to pass the vehicles in the southbound lanes, but there was oncoming traffic. He stated the vehicle merged back into the northbound lanes and struck a motorcycle. He stated the car continued to travel northbound and did not stop to provide information. He described the vehicle as a 2008-2012 silver Toyota with a firefighter sticker on the driver side of the rear window. A. Summers provided a sworn written statement.

The operator of the motorcycle, Michael Schmidt, was transported to Orange Park Medical Center where he was evaluated and treated for injuries sustained from contact with the roadway, including road rash and a laceration to his face.

At 2218 hours, CCSO dispatch was contacted by an uninvolved 3rd party

D/S D. Schlofman #1504 relocated to the suspect's residence at 2542 Russell Rd where he made contact with Christopher Blache, who was identified by his FL DL D/S Schlofman read Christopher Blache, suspect, his Miranda Warning from a prepared card. C. Blache agreed to speak with him. C. Blache stated

I observed there was blue and white transfer paint on the front of Vehicle 1 that appeared to come from the motorcycle. I observed a white and blue vehicle part that appeared to come from the motorcycle lying on the ground near Vehicle 1. C. Blache stated
