The defendant entered the business of Spencer Gifts at the Orange Park Mall, 1910 Wells Rd and attempted to purchase a pair of socks using a counterfeit \$100.00 bill. The store clerk refused to accept the note and advised the defendant the note was counterfeit. The defendant told the clerk the note was washed by his girlfriend and that is why it looked different. He left the store and proceeded to the business of FYI where he again attempted to purchase merchandise with the counterfeit \$100.00. The clerk did not accept the payment and advised the defendant the note was counterfeit. Again he told the clerk the money had been washed by his girlfriend but the clerk did not accept the money. He left the store and proceeded to the Business of Rue 21 and made a purchase of sunglasses with the counterfeit \$100.00 receiving \$93.59 change back. He left the store and proceeded to the business of Bath and Body Works and made a purchase of lotion and received \$87.50 back in change. Once the
